THE PROGRAM ENABLES THOUSANDS OF YOUNG MEN AND WOMEN WHO HAD LEFT SCHOOL TO CONTINUE THEIR STUDIES. IN ADDITION, QUESTSCOPE DEVELOPED ONE OF THE LARGEST CIVIC ENGAGEMENT PROGRAMS IN JORDAN, TRAINING 4,000 STUDENT VOLUNTEERS FROM JORDANIAN UNIVERSITIES TO MENTOR 6,000 YOUNG PEOPLE AT RISK OF JUVENILE DELINQUENCY.
